**Monthly Business:**

1. Approval of the **Financial Statement** for the month of **November**. A motion to approve was made by Councilman Cape. A second to the motion was made by Councilman Thomas. All councilmembers present approved the motion.
2. Approval of the **Financial Statement** for the month of **December**. A motion to approve was made by Councilman Thomas. A second to the motion was made by Councilman Ivie. All councilmembers present approved the motion.
3. Approval of the Draft Copy of the **December** minutes. Motion to approve with corrections made by Councilman Ivie. A second to the motion made by Councilman Thomas. All members present approved the motion.

**Old Business:**

1. **City Park:** Mayor Thomas reported that it had been cold outside therefore it had not been very productive.

Councilman Ivie noted that a big red oak had uprooted and some other trees had blown down. Councilman Ivie also noted that there had been some sawing close by.

Councilwoman Dawe reported that she had challenged Bishop Mayor and Council to a ball game to dedicate the park.

Councilman Cape reported that a citizen had asked about the poles on each end of the park. At this time there were no street lights on these poles.

Mayor Thomas stated that it would depend on where the lights are needed.

Councilwoman Dawe asked who could play on the teams. It was noted that it should be residents of the two towns. It was also noted that a liability release for would be needed for each player.

### **New Business:**

2. **Cell Tower:** Mayor Thomas reported that the Cell Tower conditional use permit would be expired in February. Mayor Thomas also stated that a representative of the company had asked for a years extension.

A motion was made by Councilman Cape that the extension under the existing guidelines will be given for a period of 12 months. A second was made to the motion by Councilman Ivie. Councilmen Cape, Ivie and Thomas approved the motion. Councilwoman Dawe abstained.

3. **Election/Application Fee:** Mayor Thomas reported that this was election year and as always a fee would need to be set for the application fee. In the past the fee has been one dollar.

Councilwoman Dawe made a motion the fee be set at one dollar. A second to the motion was made by Councilman Cape. All members present approved the motion.

### **Mayor's Update:**

1. Councilman Cape reported that the new resident on Hillsboro Road had put up a grate but had cut down the ditch.

Mayor Thomas stated the ditch needed to be pulled to run through the grate. The Mayor also stated that he would get the engineering department to inspect.

2. Councilwoman Dawe reminded the Mayor that signs were needed for Shadyfield Lane and also children playing signs.

Councilwoman Dawe stated that she had heard some complaints about the cable company.

Mayor Thomas noted that his best advice was to change to another service.

Councilwoman Dawe noted that the back of City Hall needs work. Councilwoman Dawe thought that the building needed gutters, some replacement boards and the windows needed fixing.

3. Councilman Cape asked about children playing signs and a crosswalk at the park.

Mayor Thomas stated that the signs and the crosswalk will be put in before the spring.


4. Douglas Northrop introduced the new president of Hickory Ridge subdivision as Mr. Frank Schrum.






